RE: Coal Creek Station Transfer of Ownership

Dear Mr. Regan:

This letter is to inform the United States Environmental Protection Agency (EPA) that Rainbow Energy Center, LLC ("Rainbow") has purchased Coal Creek Station from Great River Energy ("GRE"). GRE has indicated its agreement with and support for the transfer from GRE to Rainbow, subject to and conditioned upon the closing of the transactions contemplated by the Asset Purchase Agreement dated June 30, 2021 (as amended, restated or otherwise modified from time to time, the "APA") by and among GRE, Rainbow and Nexus Line, LLC ("Nexus"). This letter is submitted to notify the EPA that the transactions contemplated by the APA closed effective May 1, 2022. The assets affected by this notification associated with the coal combustion residuals (CCR) rule in 2015 and the amendments to that are listed below as follows:

- Upstream Raise 91;
- Upstream Raise 92;
- Drains Pond System; and the
- Southeast Section 16 Landfill

The facilities listed above have all the documentation required by the CCR rule posted on GRE's publicly accessible website located at <https://ccr.greatriverenergy.com/>. Effective May 1, 2022, all the documentation required by the CCR rule will be posted on Rainbow's publicly accessible website, which is located at the following address <https://ccr.rainbowenergycenter.com/>. In addition to this notification, a copy of this letter has been placed on Rainbow's publicly accessible website to allow the public to view this submittal to the EPA informing you of the APA and website update. The North Dakota Department of Environmental Quality will also receive a copy of this notification as they regulate the solid waste facilities in the State of North Dakota including the facilities outlined above.
